# MOTORCYCLE BUZZZ 2024 Zero



Zero Motorcycles has recently pulled the wraps off its highly-anticipated 2024 lineup and it's not just an upgrade – it's a revolution! The spotlight shines on three revamped models, each geared to redefine the riding experience. From rookies to road warriors, there's an electric motorcycle for every enthusiast tailored to both needs and budgets.

#### Model S: Electrifying Power Boost

Leading the charge is the all-new Model S, boasting a complete makeover with a fresh motor, an upgraded battery pack and a sleek new look. The 14.4kWh battery pack delivers double the capacity of its predecessor, promising an exhilarating ride with a power surge from 46 to 68 hp and a torque jump from 78 to 97 lb. / ft.. Top speed? A thrilling 104 mph..

The claimed ranges are impressive – 154 miles in urban settings, 113 miles in mixed conditions, and 101 miles on the highway. Charging times vary, with a standard household outlet requiring around nine hours, while a 6kW rapid charger can get you to 95 percent in just under an hour and a half.

The chassis specifics are yet to be detailed but expect top-notch components similar to the previous model. The Model S is set to appeal to a broader audience with a reduced seat height of 31 inches. However, the extra battery capacity comes with a weighty addition, now at 492 pounds. Priced at \$14,995, the Model S will be available in a stylish white and silver paint scheme.

#### **DS Line: Off-Road Thrills**

Building on the success of last year's DSR/X adventure bike, Zero introduces two new models in the DS line-



the DSR and DS. These dual sport wonders feature reinforced chassis, upgraded Gates carbon belt drives and off-road-oriented features for an adrenalinepumping experience.

The DSR flaunts a brand-new 15.6kWh battery pack, claiming a city range of 155 miles and a mixed city/ highway range of 100 miles. The new 80 hp/144 lb. / ft. motor propels it to a top speed of 104 mph. With a dramatically redesigned appearance, including a large upper fairing and an enclosed cockpit, the DSR is priced at \$19,995 and will be available in silver.

For those seeking the gateway into Zero's dual sport lineup, the all-new DS fits the bill. With a revamped 14.4kWh battery pack and increased power, it promises a city range of 144 miles and a mixed city/highway range of 107 miles, reaching a top speed of 104 mph.. Despite identical seat height to the DSR, the weight increases to 527 pounds due to the larger battery pack. The DS, available in the captivating Quicksand color, comes with a price tag of \$15,995.

#### **Global Appeal: Adapting to Licensing Laws**

For riders beyond the US borders, Zero is rolling out models conforming to tiered-licensing laws like A2 (47 hp max). Riders can later upgrade at the dealership to unleash full A3 or A-level performance, aligning with regional rules and progression through the tiers. In certain areas, the Model S and DS are also available in an 11kW configuration.

Gear up, fellow bikers! The 2024 Zero Motorcycles lineup is a testament to the future of electrifying rides. Experience the thrill, embrace the power!
